**MAIN SERVICES**

**Basic Service Fee .....\$555**

This fee is included in the charges for direct cremation, direct burial, and shipping/receiving. This fee includes overhead, obtaining appropriate information and signature on death certificate, filing the death certificate and permit and storage of remains up to 7 days.

**Direct Cremation .....\$1250**

Includes removal of remains, completing the death certificate, obtaining the doctor or coroner's signature on the death certificate, filing the death certificate and disposition permit with the local health department, cremation container and cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of material like fiberboard or composition material (with or without an outside covering). The containers we provide are cardboard. If the consumer provides the container, cremation is \$1130\*, but for cremation containers consisting of material other than cardboard, there are additional crematory fees. There are additional crematory charges for remains weighing in excess of 250 lbs.

**Direct Burial .....\$1605\*-2400\*\***

Includes removal of remains, completing the death certificate, obtaining the doctor or coroner's signature on the death certificate, filing the death certificate and disposition permit with the local health department and non-witnessed delivery of remains to a local cemetery.

Cemetery and casket cost not included. **TAX & FILING FEE NOT INCLUDED**

Includes minimal preparation of remains (without embalming, add an **additional \$150** for autopsied cases) and use of the chapel for 1/2 hour with cremation directly thereafter

**Private Memorial Charter .....\$1000**  
 For committal of ashes to the sea. United States Coast Guard certified and inspected vessel.  
 Up to 10 passengers.

**Domestic Shipping .....\$1880**  
 Includes removal, embalming, completing and filing death certificate, disposition permit and  
 delivery of the remains to airport **(airfare, shipping tray or casket not included)**

**International Shipping .....\$2500**  
 Same as domestic shipping with preparation of consulate paperwork, consulate fees, casket,  
 airtray & dressing are not included.

**Receiving Remains from another Funeral Home .....\$1500**  
 Includes transfer from local airport, temporary shelter of deceased, and non-witnessed van  
 delivery to cemetery. **(Hearse, graveside service, and state filing fee not included)**

**Embalming .....\$550**  
 Embalming is not required by law. Embalming may be necessary, however, if you select certain  
 funeral arrangements, such as a funeral with viewing. If you do not want embalming, you  
 usually have the right to choose an arrangement that does not require you to pay for it, such as  
 direct cremation or direct burial.
